## Whiz Collis

We had a lively and well attended AGM last November, with before it, a useful workshop on issues raised by Statutory Registration led by Eric Whit-

ton. Using a mixture of personal work, brainstorming, and small and large group discussion, we worked on the subjects of ethics and protecting the client, The Nuts and Bolts of Registration, Who's in and Who's Out. Coming back to the big group we shared conclusions and worries about the subject from each group.

The afternoon meeting was extremely well attended and we also had a tremendous postal vote response. This brought up some queries about the way people had been canvassed by only 'one side' of the argument against registration, whereas those attending the meeting had heard both. The board will discuss this point and report to the next general meeting.

Reports from officers gave a picture of the general good health of AHPP, though there were some worries about our relationship with UKCP and about what has been seen as a desire to centralise power to the governing body and take it away from the sections. Your representatives are fighting this!

Proposals voted on, after much debate, were as follows (somewhat condensed here through lack of space):

- 1. That AHPP become a sponsoring organisation for the proposed national register of counsellors. This motion passed.
- 2. That AHPP renounce the policy of pursuing statutory registration. This motion failed.
- 3. That AHPP commit itself to a policy of discussion and review, to be followed by a referendum on the issue of statutory registration. This motion failed.
- 4. That AHPP set up a working party to define organisational core beliefs. This motion passed.
- 5. As 4, only to look into ways of resolving accreditation, complaints and ethical issues. This motion passed.

6. That AHPP set up a working party to establish a national register of accountable therapists working in different ways from UKCP. This motion failed.

There were other proposals and amendments to the complaints procedure and the Constitution.

Officers were elected as follows: Chairperson Whiz Collis; General Secretary Christopher Coulson; Treasurer Michael Preisinger; Ethics Officer Eric Whitton; Membership Officer John Rowan. A new Board was re-elected.

Just because Proposals 2 and 3 failed at the meeting, this does not mean that the matter has gone away. We shall take very seriously the views of those members who are worried about statutory registration for psychotherapists and will be discussing in the board what we can do to address this. I also want to assure those with opposing views that there is no desire to withdraw from UKCP.

Enclosed in this issue of *Self & Society* is the full programme and booking form for the 12–14 April 1996 Conference at Leicester. There are good discounts for early booking, so why not make the decision now to come and join us?
